Following the questions, Max introduced Bill Bennett from IBM. Bill opened with a presentation on what is going right for IBM.

The Value Point line of PCs has helped IBM regain market share lost to Apple Computer. The RS/6000 continues to beat its competition. IBM shipped its 200,000th AS/400 in the fourth quarter of 1992. IBM is building an AS/400 every twelve minutes.

Too often, we only hear about the things that are going badly. Large systems are declining and IBM will be cutting in that area. The rest of the Company is very healthy. Locally, IBM is doing very very well.

When ask if he foresaw cuts in the IBM midrange, Bill indicated that he foresees the AS/400 continuing to grow at the rate of 30 to 70 percent per year.

Robin Van Wagenen then went on to discuss the progressive architecture of the AS/400, which includes its object orientation. IBM is making every effort to protect the customers investment in application programs while providing new functions and features. New technology is being delivered as soon as it is available instead of being held back by marketing. The AS/400 will stay on the leading edge of technology.
