DISASTER RECOVERY

Over the course of the last year the officers of the Users

Group have discussed several times how the Users Group might encourage its members to work on their disaster recovery plans. Earlier this year, we invited Charlie Fox from First Security Bank to discuss disaster recovery in general. This month we are kicking off what we hope will be a monthly column to encourage users to document their systems, review, and try their recovery plans. An untried plan is almost like having no plan.

Let's start out by documenting our system unit configuration. For users who are on OS/400 Version 2, IBM has provided a brief set of instructions on page 12-46 of the Application System/400 System Operator's Guide. these instructions, IBM forgot to tell you that you will need to be signed on as the security officer (QSECOFR) or the service representative (QSRV) in order to access the Work with Hardware Products (WRKHDWPRD) command.

We encourage you to print your system unit configuration at least twice. You should retain a copy on site and you should send a copy off site just in case anything happens to your computer center. You might consider keeping a copy at another business location or possibly at home, just don't keep all your copies at the same location.

If you are not on OS/400 Version 2 or if you would like help printing your system unit configuration, contact your IBM service representative.

TIPS

Before upgrading the Operating System to Version 2 Release X.X, Library QOPS should be removed from any library lists and also deleted from the system. QOPS is not used beyond Version 1 Release 3.0.

AS/400 SOFTWARE RELEASE PROCESSING CHARGES

On May 25, 1993 IBM announced AS/400* Software Release Processing Charge. These charges apply only to release updates on stacked tapes. Current

customers who are on Version 2 Release 2 (V2R2) will not be charged until they order Version 2 Release 3, which is available in December of 1993. Customers who upgrade from V2R2 to V2R2+ will NOT be charged for V2R2+ distribution. Customers who have remained on Version 2 Release 1 will be charged a processing charge when they order a new release. Customers moving from Version 1 to Version 2 will pay the normal Version upgrade charges -- release processing charges will not apply.

The Charges are as follows:

1/2" 6250 BPI = \$375 1/2" 1600 BPI = \$580 QIC 120 = \$375 QIC 525 = \$195 1/2 CART = \$220 8 mm = \$195
